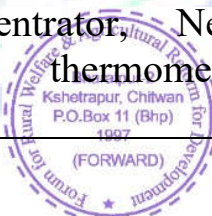

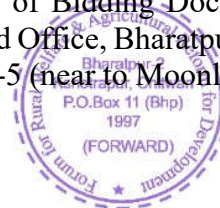

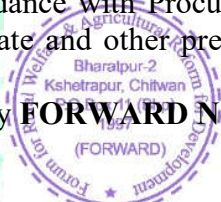

- D. Bids must be submitted in sealed envelope having required documents for eligibility at or before 17:00 pm August 08, 2021 (Shrawan 24, 2078) to FORWARD Nepal, Head Office, Bharatpur-2, Kshetrapur, Chitwan or Project Office, Rupani Road, Rajbiraj-8, Saptari and Field Office, Chandrapur-5 (near to Moonlight School), Rautahat. Bids received after the deadline shall not be accepted.
- E. Bidder must provide individual sealed quotation for each Bid no. FN01/NPL 1066-19 and FN02/NPL 1066-19. If any firm or bidder wishes to bid in both bids, the firm or bidder must provide complete document in separate sealed envelope for each bid.
- F. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at **FORWARD Nepal, Field Office, Chandrapur-5**, Rautahat at 10:00 AM August 09, 2021 (Shrawan 25, 2078) for bid no. FN01/NPL 1066-19 and FN02/NPL 1066-19
- G. Bid must be valid for 90 days for serial no. 1 and serial no.2 counting from the day of bid opening. Bid security, amounting mentioned above, shall be valid for minimum 90 days
- H. Bids for serial no. 1 and 2 should be submitted separately in a sealed envelope. Bidder must ensure to supply materials within 2 weeks after receiving supply order or purchase order.
- I. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the name of **FORWARD WHH-NPL-1058-18**, Current A/c No. **6101524685576013** at **Machhapuchhre Bank Ltd., Rajbiraj Branch, Saptari** and should submit the original receipt of the deposited amount of cash along with the Bid. - K. FORWARD Nepal reserves the right to accept or reject wholly or partly any or all the bids without assigning any reason whatsoever and also can amend and correct any discrepancies or error in bid documents, bid notice or any other documents.
- L. Matters not covered in this tender notice shall be in accordance with Procurement Policy of FORWARD Nepal or Welthungerhilfe (WHH) as appropriate and other prevailing rules and regulations of Nepal.
- M. Tenders received will be evaluated by a committee formed by **FORWARD Nepal**



# Section I. Instructions to Bidders

**I.1 Scope of Bid:** The Purchaser (FORWARD Nepal)/NSV-II Project, Rautahat & Saptari (NPL1066-20/BMZ/WHH issues this Bidding Document for the supply of Goods/materials at Paroha municipality of Rautahat district and Rajgadh Rural Municipality of Saptari district and portal incidental there to as specified in Section III, Price Schedule I & II of Requirements.

**I.2 Fraud and Corruption:** Anticorruption related laws and policies require that project's officials (including beneficiaries of funds), as well as bidders, suppliers, and contractors and their sub-contractors under BMZ/WHH financed contracts, observe the highest standard of ethics during the procurement and execution of such contracts. Any dispute of these policy and government anti-corruption law are considered as offensive action and crime. In pursuance of this policy, this bidding document;

- will reject bid(s) if it determines that the bidder has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- will sanction a firm or individual, including declaring ineligible, for a stated period of time, to be awarded a BMZ/WHH financed contract if it at any time determines that the firm has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for, or in executing, this bidding.

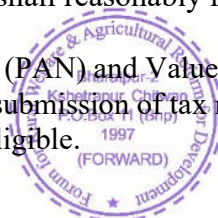
The Bidder shall not carry out or cause to carry out the following acts with an intention to influence the implementation of the procurement process or the procurement agreement:

- I. give or propose improper inducement directly or indirectly,
- II. distortion or misrepresentation of facts,
- III. engaging in corrupt or fraudulent practice or involving in such act,
- IV. interference in participation of other competing bidders,
- V. coercion or threatening directly or indirectly to cause harm to the person or the property of any person to be involved in the procurement proceedings,
- VI. collusive practice among bidders before or after submission of bids for distribution of works among bidders or fixing artificial/uncompetitive bid price with an intention to deprive the Employer the benefit of open competitive bid price,
- VII. contacting the Employer with an intention to influence the Employer with regards to the bids or interference of any kind in examination and evaluation of the bids during the period from the time of opening of the bids until the notification of award of contract.

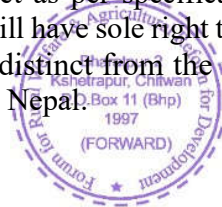
FORWARD Nepal may **blacklist** a Bidder for its conduct for a period of one (1) to three (3) years based on grounds and seriousness of the act committed by the bidder. A bidder declared blacklisted and ineligible by FORWARD Nepal shall be ineligible to bid for a contract during the period of time determined by FORWARD Nepal.

**I.3 Eligible Bidders:** This Invitation for Bids is open to eligible Bidders who are registered in Nepal as private business entity/firm/company and can supply the above required items. A Bidder shall not have a conflict of interest. A Bidder that is under a declaration of ineligibility by FORWARD Nepal, at the date of the deadline for bid submission, shall be disqualified. Bidders shall provide such evidence of their continued eligibility satisfactory to the FORWARD Nepal, as the FORWARD Nepal shall reasonably request.

Bidder who has obtained Permanent Account Number (PAN) and Value Added Tax (VAT) registration certificate(s) and Tax clearance certificate or proof of submission of tax return from the Inland Revenue Office, firm registration and renewable shall only be eligible.



**I.4 Eligible Goods and Related Services:** All goods and related services to be supplied under the contract are eligible, unless their origin is from a country specified in the Bid Documents. Quality of the goods and related services should be met as per specification, which will be national standard as far as possible. FORWARD Nepal will have sole right to inspect and evaluate quality of goods. The origin of goods and services is distinct from the nationality of the Bidder. In case of serial no. 1, the origin of good should be Nepal.



## Section II: Contents of Bidding Document

The Bidding Document consist of Parts 1, 2 and 3, which include all the Sections indicated below, and should be read and prepared bidding document accordingly.

### II.1 Bidding Procedures

**II.1.1 Instruction to bidders:** Discussed some points above in section 1.

FORWARD Nepal will reject any Bid submission if the Bidding Document is not properly filled and submitted to designated offices. Hence, The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Document. Failure to furnish all information or documentation required by the Bidding Document may result in the rejection of the Bid.

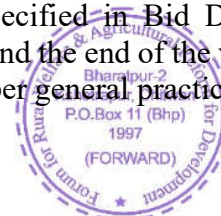
A prospective Bidder requiring any clarification of the Bidding Document may contact by email at [info@forwardnepal.org](mailto:info@forwardnepal.org) until August 04, 2021. But no phone call will be entertained.

FORWARD Nepal may amend the bidding document at any time prior to the deadline for submission of the Bids. Hence bidders are requested to visit our website [www.forwardnepal.org/announcements](http://www.forwardnepal.org/announcements) regularly within deadline.

### II.2 Preparation of Bidding Documents

Bidder are requested to carefully read these instructions, so that their bid document will not be rejected.

- A. Cost of bidding document preparation: Bidder has sole responsibility.
- B. Languages: This bidding document is prepared in English. Bidder may apply either in Nepali language or in English, and bid documents applied in other languages than Nepali and English will be rejected.
- C. All required forms must be duly filled, which includes submission form, bidder information form, price schedule, bid security form, conflict of interest declaration form along with authorized signature, contact details and stamp.
- D. FORWARD Nepal denies accepting alternative bid documents. If any bidder submits alternative bidding documents, FORWARD Nepal will have right to reject or accept lowest price and quality of bidding document.
- E. Bidder can apply for both bids. But Bidder must prepare separate documents for each bid no. and bid name.
- F. If any bidder misses to provide price of any item or related service, FORWARD Nepal will have right to include or reject for further evaluation of the bid.
- G. Bid Price: This bidding will be decided on unit price of goods or related service rather than total bidding amount. Hence, bidder must provide unit price in both figure and words. If bidder write different amount in figure and words, the amount in words will be considered.
- H. This is national bidding. Hence foreign companies cannot apply this bid.
- I. **Currency:** Bidder must use Nepali currency.
- J. Document of bidding: To establish their eligibility, Bidders shall complete the eligibility declarations in the Bid Submission Sheet, Bidding Forms; and submit the copy of the documents as **specified in this Bid Documents**.
- K. Bid shall remain valid for a period of three months after deadline of the bid submission.
- L. The Bidder shall furnish as part of its bid, in original form a Bid Security as **specified in this Bid Documents**. The bid security shall be a demand guarantee in any forms at the Bidder's option i.e., original copy of an unconditional bank guarantee or original copy of cash deposit voucher in the FORWARD Nepal's Account as specified in Bid Documents. The Bid Security shall be valid for minimum ninety days beyond the end of the validity period of the bid. Thereafter, the Bid Security may be forfeited as per **general practice** of bid security.

- M. The Bidder shall prepare one original of the documents comprising the Bid as described and clearly mark it "ORIGINAL." In addition, the Bidder shall submit copies of the Bid, in the number *specified in the Bid Documents* and clearly mark them "COPY." In the event of any discrepancy between the original and the copies, the original shall prevail.
- N. The original and all copies of the Bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder.
- O. Sample of each item to be made available in case of oxygen concentrator catalog should be made available

### II.3 Submission and Opening of Bids

**A. Mode of Submission:** Sealed hard copy in the above mentioned offices of FORWARD Nepal only. Electronically submitted bid is directly disqualified. Bidder is suggested to provide following detail, while submitting bidding documents. Bidder is also suggested to get a received note from FORWARD Nepal with organization stamp.

1. Name of Firms with address
2. PAN/VAT Number

**B. Marking in Envelopes of Bid:** The inner and outer envelopes shall bear the name and address of the Bidder; be addressed to the FORWARD Nepal, and bear a warning "BIDDING DOCUMENT: DO NOT OPEN BEFORE THE TIME OF BID OPENING".

**C. Deadline for Submission of Bids:** Bids must be received by the Purchaser at the address and no later than **August 08, 2021 at 17:00 pm.**

**D. Modification and Withdraw:** A bidder may withdraw, or modify its bid after it has been submitted. Bidder must provide written hard copy application for withdraw or modified bid in sealed envelope with clearly written MODIFICATION before deadline.

**E. Opening of Bids:** FORWARD Nepal shall conduct the bid opening in public in the presence of bidder or its representative who chose to attend at the address, date and time **specified in the Bid Documents**. If bidder or its representative will not present, the bidding opening will not be postponed.

### II.4 Evaluation and Comparison of Bids

Bids shall be considered not responsive, if; the bid is not submitted in the bid document issued by FORWARD Nepal.

- a) The bid is not properly sealed.
- b) The bid not submitted with the Bid Form duly filled and signed in the complete document as per instructions.
- c) The bid is not submitted within the specified date/time for submission of bids.
- d) The bid is not submitted along with the bids security as specified in this bidding document.
- e) The bid is not complied with the instruction specified in the invitation for bid and notice Published.
- f) Terms of payment and Destination of Delivery of goods supplied are different from those specified in the Bid Document.
- g) The bidding document do not have required documents of bidder mentioned in eligibility criteria.

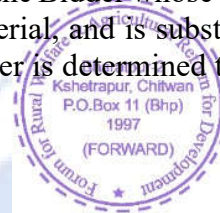
